- 6. New Business Ordinances for First Reading
 - a. 2022-002 AMENDING ORDINANCE 2022-001.

Ms. Forrester made a motion to approve Resolution 2022-002, authoring a development agreement with C4 Enterprises. Mr. Powell seconded the motion. All were in favor. The vote was 5-0.

b. 2022-003 – PURCHASE OF COMMERICAL PROPERTY

Mayor Gentry presented an option to purchase commercial property along E. Front Street. Mr. Kelley made a motion to approve the purchase, seconded by Mr. Powell. All were in favor. The vote was 5-0.

c. 2022-004 – AUTHORIZING SALE OF EQUIPMENT

Mr. Powell made a motion to approve Resolution 2022-004, seconded by Mr. Hart. All were in favor. The vote was 5-0. The equipment to be sold is commercial generators.
