Call to Order - The meeting was called to order by Mayor Gentry at 10:00 a.m.

Invocation – The Invocation was offered by Mr. Hart.

Pledge of Allegiance – Everyone stood and pledged allegiance to the Flag of the United States of America.

3. Citizen Comments and Announcements/Remarks

Ms. Ruby Cain commented on behalf of the Iva Antique Body Shop. During the month of May 2023, there were 381 check-ins to the gym. Mayor Gentry commented the new facility is still under construction and should be complete soon.

Mayor Gentry commented on a possible re-zoning issue with two mobile home parks. There was discussion concerning the Iva Planning Commission and the process to move the requests forward to allow for the developer to proceed with a new development.

There was discussion concerning the street lamp that has been damaged across the Iva Post Office. Mr. Hart made a motion to remove the lamp, seconded by Mr. Powell. All were in favor. The vote was 4-0.
